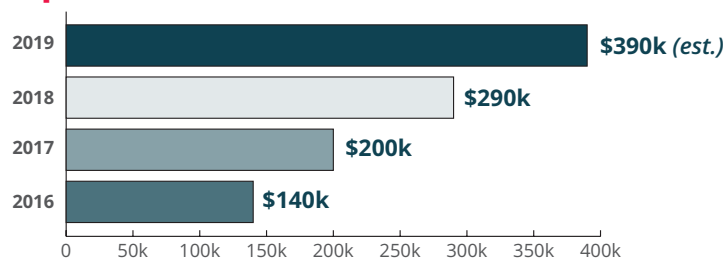

Relational Results:

Mentors	105	youth received consistent guidance: <i>Life Support</i> ®
Siblings	75	children reconnected with their siblings: <i>Sib-Link</i> ®
Parents	25	moms prepared for reunification: <i>Moms Matter</i> ®
Education	10	children tutored weekly: <i>Tutor Match</i> ®
	15	youth prepared for college success: <i>College Fellows</i> ®

System Reform:

Dignity	1,000	children moved with luggage instead of trash bags: <i>Carry On</i> ®
Policy	2	child welfare bills became law: <i>Speak Up</i> ®
Placement	700	foster parents found support: <i>Care2Foster</i> ®
Education	1,000	adults, nationally & internationally, experienced what foster care feels like: <i>Life in Limbo</i> ®
